To Whom It May Concern:

Aramark Campus Services, LLC ("Aramark") will no longer be the food service provider at Saint Louis University beyond July 31, 2018. We regret to inform you that, all Aramark employees assigned to that facility will be affected.

For those hourly associates who had already been scheduled for summer layoff at the end of this spring semester (on or about May 16, 2018), nothing changes with regard to their last day of service. However, note that associates will not be recalled to return to work for Aramark at this location for the fall 2018 semester or thereafter. For those managerial associates who were expected to work beyond the summer layoff date, we regret to inform you that we expect that their employment with Aramark will end on July 31, 2018.

Accordingly, we are sending you this notice to satisfy the requirements of the Federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. ("WARN"). While we have not determined that WARN is applicable to this closing, we are providing this notice in the event that WARN is deemed to apply.

1. As a result of the non-renewal of client contract described above, Aramark expects to permanently terminate the employment of its employees at Saint Louis University as of July 31, 2018. It is our understanding that displaced employees typically have the opportunity to apply for positions with the new provider.
2. The specific job titles of our employees affected by this non-renewal of client contract, as well as the number of our employees in each job classification, are listed on the attachments to this notice.
3. There are no bumping rights applicable to these employees.
4. The name of each union representing our employees affected by this non-renewal of client contract and the name and address of the chief elected officer of each union is as follows:
