SUMMARY:

This Issuance addresses the use of the annual 70 Percent LLSIL guidelines issued by the U.S. Department of Labor, Employment and Training Administration (DOLETA), and the annual Poverty Level guidelines issued by the Office of the Secretary of the U.S. Department of HHS. These two sets of income guidelines are used, alternately, as circumstances require and in conjunction with the criteria in Section 3(36)¹ of WIOA² to determine low-income eligibility for WIOA Title I programs. In the past, the Office of Workforce Development (OWD) has created a new Issuance twice a year to mark the release of these guidelines by the two federal agencies. Going forward, this Issuance will serve as guidance for applying income tests, and updated numbers will be posted electronically in the Issuances table on jobs.mo.gov as soon as they are available, without an accompanying Issuance change. Persons subscribing to electronic alerts for new Issuances will continue to receive notices when the numbers are updated.

BACKGROUND:

Under Title I of WIOA, a "Low Income Individual" is defined as one who qualifies under various criteria, including having an income for a six-month period that is below the <u>Poverty Line</u> or <u>70 percent of the LLSIL</u>, whichever is highest. The LLSIL is an income level geographically adjusted for metropolitan, urban, and rural differences, as well as family size, by the Secretary of the U.S. Department of Labor. The LLSIL is based on the Secretary's most recently issued lower-living family budget.

Title I of WIOA requires the Labor Secretary to update and publish the LLSIL tables annually in the *Federal Register* for uses described in the law, including determining eligibility for Youth. The 2018 LLSIL is given in the Federal Register, Volume 83, Number 103, May 29, 2018, pages 24495–24501.

Section 673(2) of the Omnibus Budget Reconciliation Act of 1981 [42 U.S.C. 9902(2)] requires the Secretary of the Department of HHS to update, at least annually, the poverty guidelines used as eligibility criteria by a number of federal programs, including WIOA. The 2018 HHS Poverty Guidelines may be found in the Federal Register, Volume 83, Number 12, January 18, 2018, pages 2642–2644. Their applicability is retroactive to January 11, 2019.

SUBSTANCE:

The 70 Percent LLSIL Guidelines or the HHS Poverty Guidelines are to be used in conjunction with the criteria set forth in WIOA sec. 3(36) for low-income individuals when determining eligibility or priority of service for WIOA programs. The appropriate guidelines to use for making eligibility determinations are those issued by DOLETA and HHS for the current calendar year, which will be posted as downloads associated with this Issuance and updated as subsequent guidelines are issued by the federal agencies. The notices published annually by those agencies in the *Federal Register* also may be used. OWD will continue to send electronic notifications (email alerts) to subscribers when new annual guidelines are published.

ROLES, RESPONSIBILITES, and REQUIRED ACTIONS:

Effective immediately, the current year, or most recently issued, guidelines for 70 Percent LLSIL should be used by Missouri Workforce System staff in conjunction with the HHS Poverty Guidelines—along with the WIOA criteria for "Low Income Individual"—to determine eligibility for WIOA Youth programs and priority of services for WIOA Adult programs.
