This letter is to inform you that SUPERVALU INC. ("SVU") will permanently close its operations at the SVU Distribution Center located at 7100 Hazelwood Ave., Hazelwood MO 63042. We expect the layoffs at SVU will be permanent and go into effect during a 14-day period commencing November 19, 2018 with a final group of approximately seven employees expected to terminate employment during a 14-day period commencing December 14, 2018. The entire SVU warehouse operation is being closed. There are no bumping rights at this location.

A portion of the affected employees at this facility are represented by four unions. Formal notice has been provided to the local unions and their chief elected officers. Their contact information is as follows:
