In our letter dated December 9, 2019, we informed you that our customer made a business model change to consolidate its operations, which will result in the closure of the facility operated by XPO and located at 4702 Park 370 Blvd., Hazelwood, MO 63042 (the "Facility").

We also shared that our customer's decision will result in the termination of employment for all employees at the Facility, beginning February 7, 2020. Subsequently, due to changes of our customer's plans, we also shared that the customer's decision would result in the termination of employment with XPO Logistics for all employees at the Facility during a 14-day period, beginning on April 3, 2020.

This letter is to supplement our December 9, 2019, February 25, 2020 and our April 2, 2020 letters and inform you that XPO's customer has postponed the date on which they will cease operations. Consistent with this change, we anticipate there will be a need to have employment separations at the Facility continuing on May 1, 2020, with an anticipated end of operation date at the end of May 2020. We understand that our customer continues to finalize its transition plans, but we expect that, when finalized, these plans will be permanent and will affect the operations at the entire Facility.

At this time, we anticipate that the remaining affected employees will have their employment terminated during a 14-day period commencing on May 1, 2020. A list of job titles and the number of employees currently holding affected positions accompanies this letter as Amended Attachment A. The individuals affected by these plans are not represented by any labor organization. Bumping arrangements are not available. This announcement and the above timetable are based on the best information currently available. However, various factors may still affect these plans and the timing of employment separations. You will be informed of changes as additional information becomes available.

To the extent that the above actions constitute a covered event under the Worker Adjustment and Retraining Notification Act, this letter is intended to fulfill any requirements imposed under the Act. By providing this information, we do not concede that the Act applies or that notice is required.

XPO Logistics has been informed by its customer, Prestige, that Prestige is making a business model change to consolidate its operations, which will result in the closure of Prestige's facility operated by XPO and located at 4702 Park 370 Blvd., Hazelwood, MO 63042 (the "Facility").

XPO regrets that its customer's decision will result in the termination of employment for all employees at the Facility, beginning February 7, 2020. One hundred sixty-six (166) employees will be affected by these developments (see Attachment A). We understand that Prestige continues to finalize its transition plans, but we expect that, when finalized, these plans will be permanent and will affect the operations that support Prestige at the entire Facility.

XPO anticipates that the termination of employment at the Facility will occur during a 14-day period beginning February 7, 2020. XPO has informed its workforce that although they may not bump or displace other employees working for XPO, there may be opportunities to transition to other XPO locations. This notification and the above timetable are based on the best information currently available. However, various factors may still affect these plans and the timing of employment separations. XPO will endeavor to update changes as additional information becomes available. You will be informed of changes as additional information becomes available.

This notice is intended to satisfy XPO's obligations, if any, under the Worker Adjustment and Retraining Notification Act (WARN) and all applicable Illinois statutory provisions. By providing this information, XPO does not concede that the Act applies or that notice is required.
